Course Overview & Highlights

This program partners with the MSU campus chapter of the **Foundation for International Medical Relief of Children (FIMRC)** <<http://www.fimrc.org>>. Through this partnership, students volunteer their time and skills to support FIMRC's mission of providing access to medical care to millions of underprivileged and underserved children around the world.

Project Peru is an intensive one-week program through which students will gain experience working in a variety of care settings and community outreach efforts. Participants will live with FIMRC-affiliated homestay families and work with health professionals at FIMRC clinics and partner hospitals in Trujillo, Agallpampa and/or Huancayo, Peru. Students will have the opportunity to:

- Provide routine and acute care under the supervision of local doctors and nurses
- Develop and present health education programs for children and families
- Assist with language translation, project administration and support services
- Observe first-hand the disparities between health care resources in the U.S. and developing countries
- Expand understanding of the people, country and culture of Peru
- Learn principles that may be applied to working with other medically underserved communities

Estimated Cost: **\$1,600**

Includes: Round-trip airfare from Springfield; Study Away student fee. Separated costs not available.

Excludes: MSU tuition for 2 hours of credit (NOTE: Any student enrolled in this course and program will be assessed the MO Resident tuition rate, even if the student is not a Missouri resident); **\$1,149 FIMRC participation fee***; passport fees; misc. personal expenses.

Application due by Friday March 9, 2012; a **\$240 non-refundable deposit** will be billed to your student account.

\$1,360 balance will be billed **Fri., April 13, 2012**. The entire program fee must be paid by May 7, 2012 in order for students to participate.

* The FIMRC participation fee covers ground transportation, lodging, meals and volunteer-related activities in Peru. Students pay this fee directly to FIMRC, a 501(c)(3) nonprofit organization dedicated to improving pediatric and maternal health in the developing world through the implementation of innovative and self-sustainable health improvement programs. *A portion of the FIMRC program fee may be tax-deductible.*

Course Objectives

This international service-learning course combines academic, cultural competence and community engagement objectives in accord with Missouri State University's public affairs mission. Through this program, students will see the immense need of Peru's children and the extraordinary efforts put forth to provide them hope and good health for the future. This experience will serve as a foundation for students who wish to become more deeply involved in community and global health.

Participants in this program will:

- Be able to speak 20 words/phrases in Spanish prior to departure
- Prepare and present one educational health topic to Peruvian families, with the assistance of an interpreter
- Assist health professionals in various care settings, including hospitals, clinics, schools and homes
- Keep a daily reflection journal, to be used as the basis for a PowerPoint presentation highlighting their FIMRC medical mission experience and comparing health care in Peru and the U.S.

Course Activities & Schedule

Pre-travel Class Meetings:

Medical Mission in Peru:

Sat., May 19 - Sun., May 27, 2012

Fly from Springfield to Lima; stay overnight at a hostel in the Miraflores District; travel by bus to Huancayo, Trujillo or Agallpampa (participants will receive their itineraries upon arrival).

The program encompasses five 7-hour days of health care and education activities in various settings. In Trujillo and Huancayo, participants will be based in a large government hospital, while in Agallpampa, activities take place in a small community clinic. Participants will divide their time between the medical facilities and the surrounding community. Activities may include:

- Observing and assisting doctors on hospital rounds, in the operating room, labor and delivery area, psychiatric ward, clinics, etc.
- Recording patient vital signs and assisting with patient examinations
- Accompanying nurses on house visits
- Conducting health, hygiene, nutrition and dental education presentations at schools, orphanages, a home for young mothers, etc.
- Participating in a presentation by medical students on dengue
- Teaching English to local school children

Participants will live with FIMRC-affiliated homestay families (all participants stay together in the homestay compound). This arrangement provides for three home-cooked meals per day and the opportunity to get to know Peruvian people and culture first-hand.

Post-travel Class Meeting:

10 AM Mon., June 11 (location TBA) -

Students will hand in their reflection journals and present their PowerPoint reports to the campus and general communities. All program participants will be asked to take part in a focus group to share their impressions, ideas, experiences and suggestions for future FIMRC medical missions.

Course Requirements & Assessment of Learning

Students fulfilling the academic requirements for the course, as outlined below, will receive 2 hours of undergraduate credit for BMS 400. Grades will be based on participation in and completion of the following:

A. Discussion and Participation (30%) -

Students must attend all pre-travel, in-country and post-travel class meetings and participate fully in all assignments and activities.

B. Daily Log/Reflection Journal & Report (30%) -

Students will record their travel itineraries and experiences working with health care professionals and medically underserved populations in Peru, including documentation of one educational session for a Peruvian family. Students also will reflect on how their experiences in Peru challenged, changed or reinforced their pre-existing ideas about the social, economic, political and cultural issues affecting health care in the developing world. This journal will provide the basis for a PowerPoint report comparing Peruvian and U.S. health care systems.

NOTE: Students must use the MSU Service-Learning Reflection Journal; no credit will be given for a non-MSU log book or journal. The completed journal must be signed by the Program Director and/or FIMRC coordinator prior to submission.

C. PowerPoint Presentation (40%) -

Students will work in small groups to prepare and present a 10-minute PowerPoint emphasizing the learning experiences of the FIMRC medical mission in Peru and discussing disparities between Peruvian and U.S. health care.

Required texts: none

Application & Payment

MSU Biomedical Sciences students and others who are approved by the Program Director may apply. Instructions are included on the program application.

Please note that, while Spanish fluency is not required, any level of comprehension will be useful in communicating with the host families, medical staff and, especially, patients.

A **non-refundable deposit of \$240** will be billed to your student account upon application (due by **March 9, 2012**). The balance of the program cost (**\$1,360**) will be billed to your account on **April 13, 2012**. The entire program fee must be paid by **May 7, 2012** in order for students to participate.

The published program cost is based on rates in effect on the publication date of this flyer and may be subject to change. **Program participants agree to a potential increase of up to 10% in the program fee if costs increase before or during travel.**

Cancellation & Refund Policies

- Students who withdraw prior to **April 20, 2012**, will receive a refund of fees paid, less their deposit and any non-refundable purchases made on his/her behalf.
- If a student is forced to withdraw after **April 20, 2012**, for a bona fide medical reason, s/he will receive a refund of fees paid, less their deposit and expenses. A certificate of incapacitating illness or injury from a licensed physician is required.
- Students withdrawing voluntarily after **April 20, 2012**, or withdrawing due to medical reasons not protected under the fees refund policy, receive no refund.
- Once the program has started, students withdrawing receive no refund under any circumstances.
- All notifications of withdrawal must be made in writing and sent to the Program Director and to Elizabeth Strong at the Study Away Office, Jim D. Morris Center, Suite 403. **Non-payment of fees does not guarantee automatic withdrawal.**
- Any plans by a participant not to travel and return with the group must also be submitted in writing to the Program Director and the Study Away Office.
- The program may be cancelled if enrollment is fewer than 6 participants. In this event, students will receive a full refund.

Voucher Eligibility & Financial Aid

If you entered MSU as a freshman in 2009 or 2010, you may use the **Study Away \$500 voucher**. Students who receive financial aid through MSU may apply that aid to the program, if eligible. Contact the Office of Financial Aid at **836-5262** for more information.
